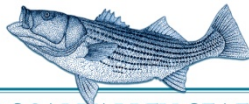

1. **Credit Terms:** Upon Approval of this application HUDSON VALLEY SEAFOOD, in it's sole discretion, and notwithstanding and request of applicant, shall have the right to terminate applicant's credit privileges under this application at any time without prior notice to application except where otherwise provided by law.
2. **Service Charge:** The entire outstanding balance due to HUDSON VALLEY SEAFOOD on all invoices shall become due in full immediately upon default in the payment of any invoice. A one and a half percent (1.5%) monthly service charge will be charged n all amounts which remain past due more than 21 days.
3. **Dishonored Checks:** Dishonored checks due to insufficient funds on deposit with buyer's bank, or a check issued with a non existing account with a band, or a check dishonored for any reason, may result in legal actions and additional damages of twice the face amount of buyer's check pursuant to section 11-104 of the New York State General Obligations Law, or any other applicable State Statutes. **Attorney's Fees:** Buyer will pay HUDSON VALLEY SEAFOOD all costs and expenses, including attorney's fees of twenty five percent (25%), which are incurred in attempting to collect from buyer the amount due for any purchases made by the buyer from seller.
4. **Change of Ownership:** Notification of any changes in ownership will immediately be sent by registered mail, return receipt to: HUDSON VALLEY SEAFOOD, 30 Valley Ave, Central Valley, NY 10917, Attention Credit Manager.
5. This agreement and any claims or disputes arising there under shall be construed and determined pursuant to the laws of the State of New York. Customer agrees that any litigation against HUDSON VALLEY SEAFOOD will be brought in a court of competent jurisdiction in the County of Orange, State of New York.
